- Retirement of **Sandra Crumrine** as a full-time paraprofessional, after 4 years of service in the district. Mrs. Crumrine’s last day of work will be October 17, 2025.
- Discharge **Employee #2128**, full-time paraprofessional. Employee’s last day of work was September 22, 2025. *(Employee was in their 45-day probationary period.)*
- Recommend **Angelina King** as an elementary special education teacher, bachelor’s degree, step 1, \$48,885, effective upon release from her previous employer, in accordance with the collective bargaining agreement and receipt of required employment documents. *(This is an added special ed position.)*

Agreement with ProCare Therapy to provide SLP services to the District, for a period of one year.
